**MEMORANDUM OF UNDERSTANDING REGARDING
CONTINUING OBLIGATIONS OF THE CIA UNDER THE JFK ACT**

WHEREAS the operations of the Assassination Records Review Board ("Review Board") cease on September 30, 1998 in accordance with the President John F. Kennedy Assassination Records Collection Act of 1992, as amended, 44 U.S.C. § 2107 ("JFK Act");

WHEREAS the JFK Act provides that "the provisions of this Act [other than those pertaining to the appointment and operation of the Review Board] shall continue in effect until such time as the Archivist certifies to the President and the Congress that all assassination records have been made available to the public in accordance with [the] Act" (JFK Act § 12); and

WHEREAS the Central Intelligence Agency ("CIA"), the Review Board, and the National Archives and Records Administration ("NARA") seek to ensure that the CIA completes its continuing obligations under the JFK Act in a timely fashion;

IT IS HEREBY AGREED by the CIA (including any successor intelligence agency), the Review Board, and NARA that:

1. For purposes of this Memorandum of Understanding ("MOU"), the JFK Assassination Records Collection ("JFK Collection") refers to the collection of processed and declassified assassination records at NARA in College Park, Maryland. The "Protected Collection" at NARA refers to the collection of assassination records that have been postponed for release under Section 6 of the JFK Act.
2. All CIA records identified as assassination records under the JFK Act will be placed in the JFK Collection at NARA by September 30, 1998 unless otherwise noted in this MOU. In addition, the CIA may retain reference copies of any records that it sends to the JFK Collection or the Protected Collection.
3. The CIA will transmit the following assassination records to the JFK Collection after September 30, 1998:
 - a. Certain documents from the CIA-House Select Committee on Assassinations (CIA-HSCA) Sequestered Collection (both hardcopy and microfilm sets), most of which were voted on by the Board in September 1998 and which must still be processed for transmission to the JFK Collection. The CIA will ensure that, by October 30, 1998, the balance of non-duplicate documents from the CIA-HSCA Sequestered Collection

(both hardcopy and microfilm sets) will be placed in the JFK Collection.

b. Duplicate documents within the CIA-HSCA Sequestered Collection (both hardcopy and microfilm sets).¹ The CIA will ensure that, by September 30, 1999, duplicate copies of documents from the CIA-HSCA Sequestered Collection (both hardcopy and microfilm sets) will be placed in the JFK Collection.

c. Duplicate documents within the working files of former CIA officer Russ Holmes. The CIA will ensure that, by December 31, 1998, duplicate copies of documents from the Russ Holmes working files will be placed in the JFK Collection.

d. The audio tapes, and any transcriptions or summaries made by the CIA, from surveillance of certain Soviet and Cuban diplomatic facilities in Mexico City for the period November 22, 1963 to January 1964. These tapes (approximately 185), and any transcriptions or summaries, shall be placed in the JFK Collection by September 30, 1999. The CIA will submit these tapes to the JFK Collection on a rolling basis, as the CIA completes review of individual tapes. Any postponements shall be identified to NARA and postponed information forwarded to the Protected Collection in accordance with Section 5(e)(2) of the JFK Act.

e. Working files from the DCI area, mostly from the DCI's Executive Registry, that had been compiled in anticipation of passage of the JFK Act. These working materials, which consist mostly of duplicate documents, will be placed in the JFK Collection by December 31, 1998.

f. A document containing a list of names and cryptonyms created by the HSCA staff. Given the detailed nature of information in this document (RIF No. 104-10061-10115), the Board agrees that this can be processed by December 31, 1998.

g. CIA's records regarding the JFK Act, as follows: certain CIA records reflecting, or relating to, its work under the JFK Act from the official Historical Review Group (or Historical Review Program) files on the JFK Act and from the working files of HRP's JFK Act Project Chief, Barry Harrelson; previously identified cables from the CIA to the field

regarding requests under the JFK Act; and the completed certifications of compliance executed by each of the directorates and the DCI office. These records will be transmitted to the JFK Collection by September 30, 1999. Microfilmed copies of any postponed documents will be provided to the Protected Collection by September 30, 1999.

h. Any other non-duplicate assassination-related records created or discovered by the CIA after September 30, 1998. If any information contained in such records is deemed to require postponement under the terms of the JFK Act, then it will be placed in the Protected Collection.

4. The CIA will review its equities in records that have been referred to it, and the CIA will cooperate with NARA and other Federal agencies to ensure that such records are released under the standards of the JFK Act and placed into the JFK Collection, or are postponed in accordance with the Act and placed in the Protected Collection. The CIA will review the following major categories of records:

- a. Church Committee records identified by the Review Board in August 1998 as being assassination-related.

- b. Records from the files of Robert F. Kennedy, maintained at the JFK Library, identified by the Library and/or Review Board as either assassination records or as records that would enhance the historical understanding of the assassination.

- c. Records of the Rockefeller Commission, maintained by the Manuscript Division at the Library of Congress, to the extent that the Library of Congress identifies assassination records that are not available as part of the Ford Library set of Rockefeller Commission documents in the JFK Collection.

- d. The Army's Investigative Records Repository file on Alfredo Mirabal Diaz.

The CIA will complete its review and recommendations for release of the major record categories listed above no later than April 30, 1999. To the extent there may be other agency documents requiring CIA review under the JFK Act, the CIA will continue to undertake such review.

5. The CIA will transmit to the Protected Collection, in accordance with Section 5(e)(2) of the JFK Act, the following original or postponed records by the dates

indicated:

- a. by September 30, 1998, the originals of all postponed records from Lee Harvey Oswald's 201 file, Office of Security file, and "A" file;
 - b. by September 30, 1998, the hardcopy original of Marina Oswald's 201 file;
 - c. by September 30, 1998, all original microfilm reels for the CIA-HSCA Sequestered Collection (The CIA and NARA will work out mutually agreeable arrangements for the secure storage of this microfilm at NARA, including provisions for holding this material in a safe with limited access. The CIA will retain the paper copies.);
 - d. by October 30, 1998, all other records with postponed information to the extent not otherwise specifically addressed in this MOU (The CIA will have the option to provide postponed information in microfilm form and to have the same security arrangements apply as in paragraph 5.c. for the CIA-HSCA Sequestered Collection microfilm reels.);
 - e. by October 30, 1998, the entire Oswald 201 file as printed from the CIA-HSCA Sequestered Collection microfilm; and
 - f. by December 31, 1998, the originals of all postponed records from the Russ Holmes working files.
6. The Review Board and the CIA have determined that certain materials reviewed under the JFK Act are not believed to be relevant to the Kennedy assassination (designated "NBR"), but nonetheless should ultimately be placed in the JFK Collection. These NBR materials are: certain files contained within the CIA-HSCA Sequestered Collection; certain CIA work files relating to Yuri Nosenko (but not related to the assassination);² certain materials within the Russ Holmes Collection; and the complete version of certain records, portions of which were designated as assassination-related by the Review Board in connection with its requests for additional records and information. These hard copy materials will be physically retained by the CIA and then forwarded to the JFK Collection for public release by October 26, 2017. The CIA will ensure the appropriate preservation of the Nosenko audio tapes in accordance with applicable NARA

standards for audio-visual records, including those standards set forth in 36 C.F.R. Part 1232. By November 30, 1998, the CIA will provide to NARA, in writing, a list of the hardcopy files being retained until 2017 and confirm the arrangements for securing this material. NARA will have the right to inspect and inventory this material for archival and administrative purposes before 2017, and these materials shall be made available for inspection by NARA upon its request.

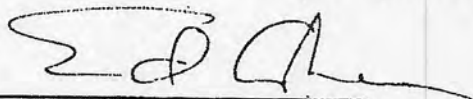
7. The CIA will cooperate and coordinate with NARA in carrying out the provisions of the JFK Act, including Section 5(g) of the JFK Act, which provides for the "periodic review" of postponed assassination records. Such review "shall address the public disclosure of additional assassination records in the Collection under the standards of the Act" (§ 5(g)(2) (A)) and "shall serve to downgrade and declassify security classified information" (§ 5(g)(2)(C)). As provided by Section 5(g)(2)(B) of the Act, "all postponed assassination records determined to require continued postponement shall require an unclassified written description of the reason for such continued postponement, which shall be provided to the Archivist and published in the Federal Register upon determination."
8. The CIA recognizes that, by October 26, 2017, "[e]ach assassination record shall be publicly disclosed in full" unless the President makes the certifications described in section 5(g)(2)(D) of the Act. To the extent that records are postponed but are to be released on a date prior to October 26, 2017, NARA will release the records on the date the Review Board set for release. If the CIA seeks continued postponement of any record due to be released by October 26, 2017 (or on an earlier scheduled release date), it will be incumbent upon the CIA to obtain from the President certification that continued postponement is necessary. Within one to six months prior to the scheduled release date, the CIA will be responsible for notifying NARA of any specific records, including records within the microfilm reels for the CIA-HSCA Sequestered Collection, for which it will seek Presidential certification of continued postponement. With respect to the NBR material identified in paragraph 6 of the present MOU, these NBR materials will be physically transferred to NARA by October 26, 2017 for release. In the event the CIA seeks further postponement of any NBR material, it will identify that material to NARA and seek Presidential certification that the material needs to be postponed.
9. With respect to the review of other agency documents referred to the CIA, the review of any new assassination records, or the periodic review of postponed assassination records, the CIA will, in good faith, continue to apply the

postponement criteria of the JFK Act as previously interpreted by decisions of the Review Board.

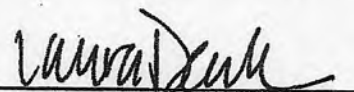
10. This Memorandum of Understanding is intended to clarify the CIA's obligations under the JFK Act in view of the expiration of the Review Board's term on September 30, 1998. This Memorandum of Understanding will not be interpreted to limit the CIA's obligations and rights under the JFK Act.

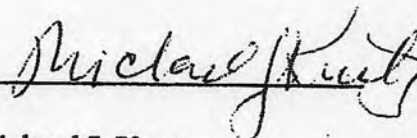

HIDDEN POWER

The Truth on JFK's Death Lies in the Weeds

As someone who has investigated and written for many years about the activities — some not very commendable — of the intelligence community, I feel it is important to acknowledge that not everything in this shadowy world is as nefarious as one might conclude.

It's easier — and, truth be told, more satisfying and fun — to tar such institutions with a broad brush, but the reality is more complicated and more nuanced. In fact, that's one of the guiding principles behind the journalism we practice at *WhoWhatWhy*.

And so it is with the *JFK assassination records* that have been released in fits and starts over the last quarter-century, with the latest, and purportedly final, batch out last December 15.

Ultimately, I guess what we all want to know is: What about the stuff showing how places like the CIA actually operate, material that gives us an inside peek into the spying, the sabotage, the blackmail, the murders — all the stuff we see in the movies? Where are those documents?

I recently had a long chat with William Bosanko, chief operating officer at the National Archives and Records Administration (NARA), the federal agency that serves as record keeper of all documents and materials created by the US federal government.

Bosanko, who started at the bottom around the time the JFK Records Act was passed in 1992 and worked his way up over the years, struck me as an ideal public servant, and typical of the many high-caliber individuals in the frequently-derided federal bureaucracy. He clearly loves his work, and is genuinely dedicated to the goal of preserving and making available the materials that document the public — and not-so-public — history of the country and its policies.

Ultimately, I guess what we all want to know is: What about the stuff showing how agencies like the CIA and FBI actually operate, material that gives us an inside peek into the spying, the sabotage, the blackmail, the murders — all the stuff we see in the movies? Where are *those* documents?

So I asked Bosanko to shine a light on the more arcane aspects of the JFK records, seeking to understand how government agencies decide what to release, what processes exist to ensure that material of public interest is not unduly withheld, why some things remain blacked out, why some documents have never been released, and even the fundamental but rarely asked question: What exactly *is* a "JFK assassination record?"

The following is an amalgam of what the NARA official told me in response to my questions (bulleted), and, more often, my own understanding of some murky and complex matters based on my personal analysis or perceptions. Any errors or misconstruals are my fault, and I'll do my best to correct them in the future.

- Why won't NARA pressure agencies to release additional documents?

Bosanko explained that aggressively looking for and demanding documents from other federal agencies is simply not part of NARA's mandate, and, moreover, NARA was never given the resources it would need to fulfill that task. Others disagree, and the Archives are currently being sued in an effort to pry loose documents that have never been released but are believed to exist. In the meantime, NARA says that outside groups and individuals should feel free to go after the individual agencies directly, and try to force them to release any documents in question.

- Why, after all these years and releases, are some small number of records *still* not available for public view?

Pretty much everything identified for release has been released. The exceptions are supposed to fall under laws not related to JFK, such as documents containing tax information or grand jury testimony.

- Who in the government is in charge of investigating what really happened to Kennedy?

Actually, no one. The Assassination Records Review Board (ARRB) of the 1990s was the last entity charged with helping investigate JFK's murder. More specifically, however, it was charged with carrying out the Congressionally-passed JFK Records Act by identifying documents that might relate to the assassination and working to get those released to the public.

Since the ARRB was disbanded, there is no authority within the government to take that further. And even the ARRB was not really dedicated to "solving" the murder, only to getting relevant paperwork released.

The very fact that no one is tasked with this historically weighty "cold case" is in itself quite sobering. It puts the entire burden on private citizens.

If anyone does see anything especially hair-raising, they will have the common sense to alert a superior, and eventually someone at a high level will have the savvy to make sure various authorities will consider a range of implications and consequences in letting a live one go.

- Could there still be a cover-up all these years later? If so, how would it work? If not, then what explains the seeming continued obstruction of information releases?

The vast majority of people with a direct personal stake in hiding anything related to Kennedy's death would be dead by now. And I cannot grasp how some dominant clique in an agency like the CIA or FBI would be able to bureaucratically justify (or necessarily care enough) to resolutely ward off disclosures on long-ago events.

More likely, nondisclosure could be on autopilot: enough rules are already baked in for those agency employees tasked with specific roles, like document review or legal oversight. Just doing their jobs will automatically prevent certain things from coming to light.

Furthermore, if anyone does see anything especially hair-raising, they will have the common sense to alert a superior, and eventually someone at a high level will have the savvy to make sure various authorities will consider a range of implications and consequences in letting a live one go. And, truth be told, how often has any institution, public or private, voluntarily aired really filthy laundry? It's just not done.

- What actually *is* an "assassination record?"

Oddly, I don't remember anyone ever bringing this up. But of course, if you're expecting the government to release all assassination records, you do need clarity on what those are — and aren't.

According to the Act, those records consist of all US government records relating to the assassination, including "any materials created or made available for use by, obtained by, or otherwise came into the possession of any state or local law enforcement office that provided support or assistance or performed work in connection with a federal inquiry into the assassination."

Since no government agency is admitting to any kind of culpability or prior awareness of a plot against the president, or any role in any subsequent cover-up — nor, more importantly, ever made any good faith effort to get at the truth, why would they even have anything that might come under this heading?

It seems that what is determined to be relevant by the agencies, and therefore must be released, is based on something unfathomable and subjective, and ultimately, deeply inadequate to the expressed aim of discovering the truth.

Of course, various government entities did "investigate," and there were internal files labeled as relating to the assassination. For example, anything they found on Lee Harvey Oswald, Jack Ruby, and so forth. Plus anything the ARRB or NARA may have decided should be included — like, recently, anything about Mexico City. (Controversy continues to rage over whether Oswald went there in the summer of 1963 and interacted with Soviet and Cuban diplomats while purportedly seeking permission to return to the USSR.)

The basis for "national security" exemptions is quite interesting. One thing that concerned the government was avoiding disclosures regarding foreign governments and agencies that cooperated with secret surveillance by the CIA in their countries. Foreign partners only agreed to these arrangements because of guarantees that such apparent violations of their sovereignty would never become public. These foreign governments worried that such activities could spark tremendous uproar, even decades later.

So sometimes, what might look like agencies protecting themselves turns out to be something entirely different.

For its part, NARA seems to do quite a good job of demanding that the agencies explain the particulars of anything they want to withhold, to good effect. Its senior officials can get access to the original unredacted documents and press for explanations on why they should not release them in whole. And this has led to progress. For example, with the most recent release, the CIA did not withhold material that it has in the

past — relating to the actual locations of its foreign stations. (That's not considered germane to the JFK assassination, but we get the information and it has research value.)

People ask me all the time whether I think the truth will be revealed by documents. No, not directly. No "smoking gun" exists that one can discover and wave in front of others to make a definitive point.

Why no smoking gun? Maybe it went up in smoke. But seriously, consider some of the many obstacles we truth-seekers face:

- The most sensitive and controversial activities and operations are highly compartmentalized on a "need to know" basis, so very few people know the truth firsthand.
- In highly sensitive activities, little is ever written down.
- Spy agencies worldwide do all kinds of things that can never be acknowledged. There is no record, and precious little institutional awareness. You know the term: "deniability."
- Typically, efforts to find specific documents that are known or likely to have existed come up dry. This may be simply because those documents were destroyed a long time ago. Document destruction is a real thing, and we've seen examples recently, including the Secret Service's *destruction of text messages* from the Trump administration.
- Agency personnel are sworn to secrecy, and also wired in such a way that they would never even consider revealing confidences about their work, no matter what. This is quite common in military and paramilitary organizations. In addition, a host of punitive measures and threats lurk for those who break these confidences. The well-publicized instances where insiders met untimely deaths have not been lost on their colleagues.

Yet, despite all this, we have many reasons to be hopeful. For one thing, intrepid, resilient, eagle-eyed researchers armed with broad knowledge can still mine for gold.

Sometimes you find something really great. For example, some years back, at *WhoWhatWhy*, we reported on a document about Earle Cabell, the man who was the mayor of Dallas at the time of JFK's fateful visit to that city, and who played a role in trip arrangements and logistics. The document showed that Cabell, a businessman who ran, among other things, a large family-owned dairy, had been approved some years earlier for *operational use* by the CIA.

That becomes even more interesting when one considers that Cabell's brother, Gen. Charles Cabell, was the deputy director of the CIA, and was fired along with his boss Allen Dulles by President John F. Kennedy. Charles Cabell was known to speak somewhat openly about his animus for the president.

Typically, though, it is the much smaller things that one comes across, and we researchers absolutely geek out on matters that would mean nothing at all to most people. Like noticing an itinerary that puts a person of interest in a place other than where they were officially said to have been.

Those little gifts can lead to embarrassment — or worse — for the powers that be.

Indeed, some years ago, an Obama administration official sent a memo warning about the risk of releasing documents. He referred to the "mosaic effect" — that it is still possible to stitch together seemingly meaningless or obscure items to generate a larger picture, even leading to a major breakthrough. That's the sort of hard, typically unsung and definitely underappreciated work that is the basis of the finest journalism and scholarship.

Today, while we tend to glorify the self-appointed narrators of history, the summarizers of and opiners on others' work; it is those laboring assiduously over research projects for long periods in relative or even total obscurity who deserve our greatest appreciation.

And in that regard, a bit of good news for researchers: NARA's holdings include 25 million cubic feet of paper from other agencies; only a portion of which is classified. Just 1 percent of that trove is digitized. But NARA requested, and Biden has agreed, to commence digitizing the entirety of the JFK collection, and that is underway. The goal is to get all of the JFK records digitized and available online this year.

I was thinking about all the work these taxpayer-funded public servants are doing as I pondered some of the mystifying anomalies and inconsistencies arising with each new batch of released documents over the years.

Often, the discrepancy can be explained by the exigencies of work.

For example, I was wondering why, in the December 15, 2022, release, many "redactions" (or blacked out sections) were accompanied by a citation of the relevant section of the JFK Records Act. These are the justifications — the reasons the government says it can continue to withhold information. I didn't recall seeing these line by line certifications with prior records releases. What gives, I wondered?

The answer is simply that with past releases, NARA staff had just too much paper to push through and too little time, and so these exemptions were essentially mass-applied to many documents at a time. Putting the specific explanation on every single redaction in the latest release represents a public service that only sufficient time and staff made possible.

This boon to future researchers, this herculean task being performed — at a time when the House GOP is proposing massive cuts in federal bureaucracy, starting with the IRS — is a reminder of a rarely appreciated side of bureaucratic endeavors. That is the value of employing people to do hard and often thankless work to help US citizens understand their own government.

§ 1290.1 Scope of assassination record.

- (a) An *assassination record* includes, but is not limited to, all records, public and private, regardless of how labeled or identified, that document, describe, report on, analyze or interpret activities, persons, or events reasonably related to the assassination of President John F. Kennedy and investigations of or inquiries into the assassination.
- (b) An *assassination record* further includes, without limitation:
 - (1) All records as defined in Section 3(2) of the JFK Act;
 - (2) All records collected by or segregated by all Federal, state, and local government agencies in conjunction with any investigation or analysis of or inquiry into the assassination of President Kennedy (for example, any intra-agency investigation or analysis of or inquiry into the assassination; any interagency communication regarding the assassination; any request by the House Select Committee on Assassinations to collect documents and other materials; or any inter- or intra-agency collection or segregation of documents and other materials);

- (3) Other records or groups of records listed in the Notice of Assassination Record Designation, as described in § 1290.8 of this chapter.

§ 1290.2 Scope of additional records and information.

The term *additional records and information* includes:

- (a) All documents used by government offices and agencies during their declassification review of assassination records as well as all other documents, indices, and other material (including but not limited to those that disclose cryptonyms, code names, or other identifiers that appear in assassination records) that the Assassination Records Review Board (Review Board) has a reasonable basis to believe may constitute an assassination record or would assist in the identification, evaluation or interpretation of an assassination record. The Review Board will identify in writing those records and other materials it intends to seek under this section.
- (b) All training manuals, instructional materials, and guidelines created or used by the agencies in furtherance of their review of assassination records.
- (c) All records, lists, and documents describing the procedure by which the agencies identified or selected assassination records for review.
- (d) Organizational charts of government agencies.
- (e) Records necessary and sufficient to describe the agency's:
 - (1) Records policies and schedules;
 - (2) Filing systems and organization;
 - (3) Storage facilities and locations;
 - (4) Indexing symbols, marks, codes, instructions, guidelines, methods, and procedures;
 - (5) Search methods and procedures used in the performance of the agencies' duties under the JFK Act; and
 - (6) Reclassification to a higher level, transfer, destruction, or other information (e.g., theft) regarding the status of assassination records.
- (f) Any other record that does not fall within the scope of assassination record as described in § 1290.1, but which has the potential to enhance, enrich, and broaden the historical record of the assassination.

§ 1290.3 Sources of assassination records and additional records and information.

Assassination records and additional records and information may be located at, or under the control of, without limitation:

- (a) Agencies, offices, and entities of the executive, legislative, and judicial branches of the Federal Government;

- (b) Agencies, offices, and entities of the executive, legislative, and judicial branches of state and local governments;
- (c) Record repositories and archives of Federal, state, and local governments, including presidential libraries;
- (d) Record repositories and archives of universities, libraries, historical societies, and other similar organizations;
- (e) Individuals who possess such records by virtue of service with a government agency, office, or entity;
- (f) Persons, including individuals and corporations, who have obtained such records from sources identified in paragraphs (a) through (e) of this section;
- (g) Persons, including individuals and corporations, who have themselves created or have obtained such records from sources other than those identified in paragraphs (a) through (e) of this section;
- (h) Federal, state, and local courts where such records are being held under seal; or
- (i) Foreign governments.

§ 1290.4 Types of materials included in scope of assassination record and additional records and information.

The term *record* in *assassination record* and *additional records and information* includes, for purposes of interpreting and implementing the JFK Act:

- (a) Papers, maps, and other documentary material;
- (b) Photographs;
- (c) Motion pictures;
- (d) Sound and video recordings;
- (e) Machine readable information in any form; and
- (f) Artifacts.

§ 1290.5 Requirement that assassination records be released in their entirety.

An assassination record shall be released in its entirety except for portions specifically postponed pursuant to the grounds for postponement of public disclosure of records established in § 2107.6 of the JFK Act, and no portion of any assassination record shall be withheld from public disclosure solely on grounds of non-relevance unless, in the Review Board's sole discretion, release of part of a record is sufficient to comply with the intent and purposes of the JFK Act.

§ 1290.6 Originals and copies.

- (a) For purposes of determining whether originals or copies of assassination records will be made part of the President John F. Kennedy Assassination Records Collection (JFK Assassination Records Collection) established under the JFK Act, the following shall apply:
 - (1) In the case of papers, maps, and other documentary materials, the Review Board may determine that record copies of government records, either the signed original, original production or a reproduction that has been treated as the official record maintained to chronicle government functions or activities, may be placed in the JFK Assassination Records Collection;

- (2) In the case of other papers, maps, and other documentary material, the Review Board may determine that a true and accurate copy of a record in lieu of the original may be placed in the JFK Assassination Records Collection;
 - (3) In the case of photographs, the original negative, whenever available (otherwise, the earliest generation print that is a true and accurate copy), may be placed in the JFK Assassination Records Collection;
 - (4) In the case of motion pictures, the camera original, whenever available (otherwise, the earliest generation print that is a true and accurate copy), may be placed in the JFK Assassination Records Collection;
 - (5) In the case of sound and video recordings, the original recording, whenever available (otherwise, the earliest generation copy that is a true and accurate copy), may be placed in the JFK Assassination Records Collection;
 - (6) In the case of machine-readable information, a true and accurate copy of the original (duplicating all information contained in the original and in a format that permits retrieval of the information), may be placed in the JFK Assassination Records Collection; and
 - (7) In the case of artifacts, the original objects themselves may be placed in the JFK Assassination Records Collection.
- (b) To the extent records from foreign governments are included in the JFK Assassination Records Collection, copies of the original records shall be sufficient for inclusion in the collection.
 - (c) In cases where a copy, as defined in paragraph (a) of this section, is authorized by the Review Board to be included in the JFK Assassination Records Collection, the Review Board may require that a copy be certified if, in its discretion, it determines a certification to be necessary to ensure the integrity of the JFK Assassination Records Collection. In cases where an original, as defined in paragraph (a) of this section, is required for inclusion in the JFK Assassination Records Collection, the Review Board may, at its discretion, accept the best available copy. In such cases that records included in the JFK Assassination Records Collection, whether originals or copies, contain illegible portions, such records shall have attached thereto a certified transcription of the illegible language to the extent practicable.
 - (d) For purposes of implementing the JFK Act, the term *copy* means a true and accurate photocopy duplication by a means appropriate to the medium of the original record that preserves and displays the integrity of the record and the information contained in it.
 - (e) Nothing in this section shall be interpreted to suggest that additional copies of any assassination records contained in the JFK Assassination Records Collection are not also assassination records that, at the Review Board's discretion, may also be placed in the JFK Assassination Records Collection.
 - (f) Nothing in this section shall be interpreted to prevent or to preclude copies of any electronic assassination records from being reformatted electronically in order to conform to different hardware and/or software requirements of audiovisual or machine readable formats if such is the professional judgment of the National Archives and Records Administration.

§ 1290.7 Additional guidance.

- (a) A government agency, office, or entity includes, for purposes of interpreting and implementing the JFK Act, all current, past, and former departments, agencies, offices, divisions, foreign offices, bureaus, and deliberative bodies of any Federal, state, or local government and includes all inter- or intra-agency working groups, committees, and meetings that possess or created records relating to the assassination of President John F. Kennedy.
- (b) The inclusion of artifacts in the scope of the term assassination record is understood to apply solely to the JFK Assassination Records Collection and to implement fully the terms of the JFK Act and has no direct or indirect bearing on the interpretation or implementation of any other statute or regulation.
- (c) Whenever artifacts are included in the JFK Assassination Records Collection, it shall be sufficient to comply with the JFK Act if the public is provided access to photographs, drawings, or similar materials depicting the artifacts. Additional display of or examination by the public of artifacts in the JFK Assassination Records Collection shall occur under the terms and conditions established by the National Archives and Records Administration to ensure their preservation and protection for posterity.
- (d) The terms and, or, any, all, and the plural and singular forms of nouns shall be understood in their broadest and most inclusive sense and shall not be understood to be terms of limitation.
- (e) Unless the Review Board in its sole discretion directs otherwise, records that are identified with respect to a particular person shall include all records relating to that person that use or reflect the true name or any other name, pseudonym, codeword, symbol number, cryptonym, or alias used to identify that person.
- (f) Unless the Review Board in its sole discretion directs otherwise, records that are identified by the Review Board with respect to a particular operation or program shall include all records, pertaining to that program by any other name, pseudonym, codeword, symbol, number, or cryptonym.

§ 1290.8 Implementing the JFK Act—Notice of Assassination Record Designation.

- (a) A Notice of Assassination Record Designation (NARD) shall be the mechanism for the Review Board to announce publicly its determination that a record or group of records meets the definition of assassination records.
- (b) Notice of all NARDs will be published in the FEDERAL REGISTER within 30 days of the decision to designate such records as assassination records.
- (c) In determining to designate such records as assassination records, the Review Board must determine that the record or group of record will more likely than not enhance, enrich, and broaden the historical record of the assassination.

Interference with Constitutionally Protected Property Rights.

Civil Justice Reform

This rule meets applicable standards in sections 3(a) and 3(b)(2) of Executive Order 12988, Civil Justice Reform, to minimize litigation, eliminate ambiguity, and reduce burden.

Protection of Children

We have analyzed this rule under Executive Order 13045, Protection of Children from Environmental Health Risks and Safety Risks. This rule is not an economically significant rule and does not concern an environmental risk to health or risk to safety that may disproportionately affect children.

Environment

The Coast Guard considered the environmental impact of this rule and concluded that under figure 2-1, paragraph (34)(g), of Commandant Instruction M16475.IC, this rule is categorically excluded from further environmental documentation. A "Categorical Exclusion Determination" is available in the docket for inspection or copying where indicated under ADDRESSES.

§ 165.T09-022 Safety zone: Lake Erie, Maumee River, Ohio.

(a) *Location.* The following area is a temporary safety zone: The waters and adjacent shoreline extending from the bow of the museum ship *SS Willis B. Boyer* then NNE to the south end of the City of Toledo Street, Harbors and Bridges Building then SW to the red nun bouy #64 then SSE to the museum ship *SS Willis B. Boyer*. A triangle as formed by positions 41° 38' 35" N, 083° 31' 54" W; 41° 38' 51" N, 083° 31' 50" W; 41° 38' 48" N, 083° 31' 58" W. All nautical positions are based on North American Datum of 1983.

(b) *Effective date.* This regulation is effective between the hours of 8:30 a.m. to 11 p.m., July 4, 2000, unless terminated earlier by the Captain of the Port.

(c) *Restrictions.* In accordance with the general regulations in section 165.23 of this part, entry into this zone is prohibited unless authorized by the Captain of the Port.

John F. Kennedy Assassination Records Collection Rules

AGENCY: National Archives and Records Administration (NARA).

ACTION: Final rule.

SUMMARY: NARA is transferring regulations providing guidance for the interpretation and implementation of the John F. Kennedy Assassination Records Collection Act of 1992 from 36 CFR chapter XIV to chapter XII without substantive change. The Assassination Records Review Board that originally issued the regulations terminated on September 30, 1998, but NARA has determined that these regulations are still required to provide guidance to agencies.

SUPPLEMENTARY INFORMATION: The Assassination Records Review Board was established by the John F. Kennedy Assassination Records Collection Act of 1992 (106 Stat. 3443). At the termination of the Review Board on September 30, 1998, its records were transferred to the Archivist of the United States. NARA continues to maintain and supplement the collection under the provisions of the Act. NARA is, therefore, the successor in function to this defunct independent agency.

The Review Board issued regulations at 36 CFR chapter XIV providing guidance on the Act (part 1400) on June 28, 1995. In this final rule we are transferring those regulations without

substantive change to a new 36 CFR part 1290 in new subchapter H. Agencies continue to identify records that may qualify as assassination records and need to have this guidance available.

Other Review Board regulations implementing Government in the Sunshine Act, FOIA, and the Privacy Act for the Board's own operations (parts 1405, 1410, and 1415) are withdrawn from the Code of Federal Regulations as unnecessary. The Board's records were transferred to NARA and are now subject to NARA regulations.

This rule is effective upon publication for "good cause" as permitted by the Administrative Procedure Act (5 U.S.C. 553(d)(3)). If the rule is not effective before July 1, 2000, the regulations of the defunct Review Board in 36 CFR ch. XIV will continue to appear in the print and electronic copies of title 36. NARA believes that delaying the effective date for 30 days is unnecessary as this rule represents a minor technical amendment and there is no substantive impact on the public or Federal agencies.

This rule is not a significant regulatory action for the purposes of Executive Order 12866 and has not been reviewed by the Office of Management and Budget. This rule does not have federalism implications and is not a major rule under 5 U.S.C. 801. As required by the Regulatory Flexibility Act, it is hereby certified that this rule will not have a significant impact on a substantial number of small entities.

Memorandum on Certifications Regarding Disclosure of Information in Certain Records Related to the Assassination of President John F. Kennedy

Memorandum for the Heads of Executive Departments and Agencies

SUBJECT: Certifications Regarding Disclosure of
Information in Certain Records Related to the
Assassination of President John F. Kennedy

Section 1. Policy. As set forth in the Presidential Memorandum of October 22, 2021 (Temporary Certification Regarding Disclosure of Information in Certain Records Related to the Assassination of President John F. Kennedy) (2021 Memorandum), in the President John F. Kennedy Assassination Records Collection Act of 1992 (44 U.S.C. 2107 note) (the “Act”), the Congress declared that “all Government records concerning the assassination of President John F. Kennedy . . . should be eventually disclosed to enable the public to become fully informed about the history surrounding the assassination.” The Congress also found that “most of the records related to the assassination of President John F. Kennedy are almost 30 years old, and only in the rarest cases is there any legitimate need for continued protection of such records.” In the 30 years since the Act became law, the profound national tragedy of President Kennedy’s assassination continues to resonate in American history and in the memories of so many Americans who were alive on that terrible day; meanwhile, the need to protect records

concerning the assassination has weakened with the passage of time. It is therefore critical to ensure that the United States Government maximizes transparency by disclosing all information in records concerning the assassination, except when the strongest possible reasons counsel otherwise.

Sec. 2. Background. (a) The Act permits the continued postponement of disclosure of information in records concerning President Kennedy's assassination only when postponement remains necessary to protect against an identifiable harm to the military defense, intelligence operations, law enforcement, or the conduct of foreign relations that is of such gravity that it outweighs the public interest in disclosure. Since 2018, executive departments and agencies (agencies) have been reviewing under this statutory standard each redaction they have proposed that would result in the continued postponement of full public disclosure, with the National Archives and Records Administration (NARA) reviewing whether it agrees that each redaction continues to meet the statutory standard. In my 2021 Memorandum, the Archivist of the United States (Archivist) explained that the COVID-19 pandemic had a significant impact on the ability of agencies, including NARA, to conduct this review and comprehensive engagement, and the Archivist recommended that I temporarily certify the records for continued postponement for a limited period. In the 2021 Memorandum, I directed the completion of an intensive 1-year review of each remaining proposed redaction to ensure that the United States Government maximizes transparency by disclosing all information in records related to the assassination, except in cases when the strongest possible reasons counsel otherwise.

(b) Pursuant to my direction, agencies have undertaken a comprehensive effort to review the full set of almost 16,000 records that had previously been released in redacted form and determined that more than 70 percent of those records may now be released in full. This significant disclosure reflects my Administration's commitment to transparency and will provide the American public with greater insight and understanding of the Government's investigation into this tragic event in American history.

(c) In the course of their review, agencies have identified a limited number of records

containing information for continued postponement of public disclosure. NARA has reviewed these proposed redactions and has coordinated with relevant consulting agencies, where appropriate, to ensure that the proposed redactions meet the statutory standard for continued postponement. The Acting Archivist has recommended certifying a small subset of the reviewed records for continued postponement of public disclosure.

(d) The Acting Archivist has further indicated that additional work remains to be done with respect to a limited number of other reviewed records that were the subject of agency proposals for continued postponement of public disclosure. The Acting Archivist believes such additional work could further reduce the amount of redacted information. The Acting Archivist therefore recommends that I temporarily certify the continued postponement of public disclosure of the redacted information in these records to provide additional time for review and to ensure that information from these records is disclosed to the maximum extent possible, consistent with the standards of the Act.

Sec. 3. Certification. In light of the proposals from agencies for continued postponement of public disclosure of information in the records identified in section 2(c) of this memorandum under the statutory standard, and the Acting Archivist's recommendation, I agree that continued postponement of public disclosure of such information is warranted to protect against an identifiable harm to the military defense, intelligence operations, law enforcement, or the conduct of foreign relations that is of such gravity that it outweighs the public interest in disclosure. Accordingly, by the authority vested in me as President by the Constitution and the laws of the United States of America, including section 5(g)(2)(D) of the Act, I hereby certify that continued postponement of public disclosure of these records is necessary to protect against an identifiable harm to the military defense, intelligence operations, law enforcement, or the conduct of foreign relations that is of such gravity that it outweighs the public interest in disclosure. All information within these records that agencies have proposed for continued postponement under section 5(g)(2)(D) of the Act shall accordingly be withheld from public disclosure. Further release of the information in these records shall occur in a manner consistent with the Transparency Plans described in section 7 of this memorandum.

Sec. 4. Temporary Certification. In light of the proposals from agencies for continued postponement of public disclosure of information in the records identified in section 2(d) of this memorandum under the statutory standard, the Acting Archivist's request for an extension of time to continue review of those records, and the need for an appropriately thorough review process, I agree with the Acting Archivist's recommendation regarding temporary postponement. Temporary continued postponement of public disclosure of such information is necessary to protect against an identifiable harm to the military defense, intelligence operations, law enforcement, or the conduct of foreign relations that is of such gravity that it outweighs the public interest in disclosure. Accordingly, by the authority vested in me as President by the Constitution and the laws of the United States of America, including section 5(g)(2)(D) of the Act, I hereby certify that all information within these records that agencies have proposed for continued postponement under section 5(g)(2)(D) of the Act shall be withheld from public disclosure until June 30, 2023.

Sec. 5. Release. Any information currently withheld from public disclosure that agencies have not proposed for continued postponement shall be released to the public by December 15, 2022.

Sec. 6. Review. (a) From the date of this memorandum until May 1, 2023, relevant agencies and NARA shall jointly review the remaining redactions in the records addressed in sections 2(d) and 4 of this memorandum with a view to maximizing transparency and disclosing all information in records concerning the assassination, except when the strongest possible reasons counsel otherwise. Any information that agencies propose for continued postponement of public release beyond June 30, 2023, shall be limited to the absolute minimum under the statutory standard. Agencies shall not propose to continue redacting information unless the redaction is necessary to protect against an identifiable harm to the military defense, intelligence operations, law enforcement, or the conduct of foreign relations that is of such gravity that it outweighs the public interest in disclosure. In applying the statutory standard, agencies shall:

- (i) accord substantial weight to the public interest in transparency and full disclosure

of any record that falls within the scope of the Act; and

(ii) give due consideration that some degree of harm is not grounds for continued postponement unless the degree of harm is of such gravity that it outweighs the public interest in disclosure.

(b) If, by no later than May 1, 2023, NARA agrees that a proposed redaction meets the statutory standard for continued postponement, the Archivist shall recommend to the President, no later than May 1, 2023, that continued postponement of public disclosure of the information is warranted after June 30, 2023.

(c) If, by no later than May 1, 2023, NARA does not recommend that a proposed redaction meets the statutory standard for continued postponement, agencies shall, no later than May 15, 2023:

(i) withdraw the proposed redaction; or

(ii) recommend to the President, through the Counsel to the President, on a document-by-document basis, that release of the information continue to be postponed, providing an explanation for each proposed redaction of why continued postponement remains necessary to protect against an identifiable harm to the military defense, intelligence operations, law enforcement, or the conduct of foreign relations that is of such gravity that it outweighs the public interest in disclosure.

(d) In the development of the recommendations described in this section, as questions arise about particular proposed redactions, NARA shall consult, as appropriate, with relevant agencies as described in section 5(d) of my 2021 Memorandum.

(e) At the conclusion of the review described in this section, any information withheld from public disclosure that agencies do not propose for continued postponement beyond June 30,

2023, shall be released to the public by that date.

Sec. 7. Transparency Plans. As part of their review, each agency prepared a plan for the eventual release of information (Transparency Plan) to ensure that information would continue to be disclosed over time as the identified harm associated with release of the information dissipates. Each Transparency Plan details the event-based or circumstance-based conditions that will trigger the public disclosure of currently postponed information by the National Declassification Center (NDC) at NARA. These Transparency Plans have been reviewed by NARA, and the Acting Archivist has advised that use of the Transparency Plans by the NDC will ensure appropriate continued release of information covered by the Act. Accordingly, I direct that the Transparency Plans submitted by agencies be used by the NDC to conduct future reviews of any information that has been postponed from public disclosure, including information in the records described in sections 2(c) and 3 of this memorandum.

Sec. 8. Publication. The Acting Archivist is hereby authorized and directed to publish this memorandum in the Federal Register.

Telephone numbers or addresses may be considered for continued postponement only if the specific information is current. Dear Ms. Knight:

On behalf of the Secretary of the Defense and in response to the President's memorandum, "Temporary Certification Regarding Disclosure of Information in Certain Records Related to the Assassination of President John F. Kennedy," dated October 22, 2021, the Department of Defense (DoD) conducted intensive joint reviews with National Archives staff of our proposed December 2021 withholds. As a result of these reviews, DoD recommends release of additional records in full, and fewer redactions in other DoD records contained in the John F. Kennedy (JFK) Assassination Records Collection. DoD assesses continued withholding of certain classified and controlled unclassified information from public disclosure beyond December 15, 2022 is necessary for parts of records originated by the Department of the Army, National Security Agency (NSA), and Office of the Secretary of Defense staff. The harm that release of this redacted information would cause, coupled with the fact that these records are themselves unrelated to the assassination of JFK outweighs disclosure for the public interest.

Each proposed redaction is identified for each record along with the justification in the enclosed updated matrices resulting from the one-year intensive review, and meets at least one of the criteria for postponement from public disclosure as described in section 5(g)(2)(D) of the President John F. Kennedy Assassination Records Collection Act of 1992 (the Act). Specifically:

- An intelligence source or method, which is currently used, or reasonably expected to be used, by the U.S. Government, and which has not been officially disclosed, the disclosure of which would interfere with the conduct of intelligence activities. Some of the records at issue identify specific nation states that continue to be targets of Signals Intelligence (SIGINT) operations. Revealing current SIGINT targets or specific sources and methods in use to target, collect, and/or process SIGINT would enable adversaries to adopt denial practices. Employment of such denial practices would impede our ability to provide SIGINT to our military forces and foreign defense partners.
- Any other matter currently relating to the military defense, intelligence operations, or conduct of foreign relations of the United States, the disclosure of which would demonstrably impair the national security of the United States. Some of the records

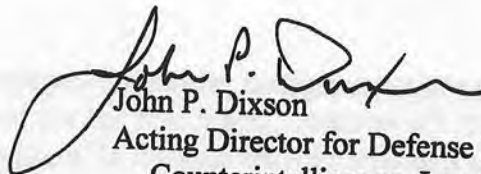

contain nuclear weapon yields, nuclear deterrence planning and foreign military partner coordination, or social security numbers of living persons.

In order to balance protections of certain information and in keeping with the intent to maximize public access and disclosure to the extent practicable, DoD proposes a "Path to Transparency" for the remaining redacted information. Rather than conducting arbitrary date reviews, DoD proposes the remaining redacted information releases be "event triggered" as it pertains to partnerships, equities, and sources and methods identified. For each of DoD's remaining redactions in the JFK Records Collection, DoD would release the information when one or more of the following events or conditions occur:

- From the date NSA determines the specific sources or methods detailed in the JFK records are no longer in use, and their release presents no risk or harm to national security.
- From the date that NSA partner(s) approve release of their equities for the NSA JFK records.
- From the date the partnership(s) or diplomatic relationship(s) are formally dissolved and the date the partner is no longer a party to a security agreement or leaves international organizations to which DoD is also a member.
- From the date when the nuclear weapons system is no longer part of the U.S. nuclear arsenal, and disclosure of weapons yields of nuclear weapons systems will not hinder U.S. nuclear war planning and civil defense.
- From the date of death of a living person.
